Proxies must be received at least 24 hours in advance of the Annual Meeting to be counted. This Proxy may be modified by writing hereon, retrieved at the Annual Meeting or revoked by written notice directed to the Board of Directors, at any time before the scheduled Annual Meeting.

Cumulative Voting:

There are three vacancies on the Board of Directors, each for a three year term. Each property owner is entitled to one vote for each of the vacancies, or a total of three (3) votes per property owned. You may cast one (1) or more votes for any candidate so long as the total cumulative votes do not exceed the "Total Votes Cast" number indicated on the front of this proxy (3 per property). A proxy voting for candidates where the number of votes given to each candidate add up to more than the "Total Votes Cast" amount indicated on front of this proxy will be disqualified and not counted in the election.

Filling Out This Proxy:

- Please only check one box in either Section I or Section II.** If you check more than one box in Section II, or you check the boxes in both Sections I and II, a conflict is created on the proxy/ballot and any voting for candidates will be disqualified.
- If you check the box in Section I, please skip Section II and then, sign, date** and indicate whether or not you will be attending the meeting at the bottom of the form.
- If you check the box in Section II, Item 1** then please vote the total number of votes you have allocated for one (1) or more of the candidates listed or which you have written-in. The total number of votes available to you have been indicated automatically on the proxy/ballot form. **Note: Each property is allowed three (3) votes to be cast for one or more candidates. Based on the number of property accounts in your name you have been allocated 3 total votes.** You must check the box if you want your votes counted in the manner in which they have been allocated to the candidates. **If the box in Section II, option 1 is not checked, and you allocate votes for the candidates without checking this box,** and if the form is properly signed and dated at the bottom, the proxy/ballot will be used for quorum purposes only. The box **(Section II, option 1)** must be checked for your votes to count.
- If you check the box in Section II, Item 2** then please list the name of the person who will be voting your proxy on your behalf for the candidates they choose, then sign and date the bottom of the proxy/ballot.
- If you check one box in Section II, either option 3A or 3B** your proxy/ballot will be voted in the manner described. Please sign and date the bottom.
 - 3A.** If you choose this option, your votes will be added to the votes of all other members choosing this option and then allocated to the candidates proportionately based on the number of votes otherwise cast, without counting any fractional votes
 - 3B.** If you choose this option, the Board, by majority vote, will determine how it will cast your votes immediately before the meeting and will disclose how the votes were allocated following the official tabulation of votes.
